# 1. The Midwest-Great Lakes SER Chapter 6th Annual Meeting – Friday March 28 – Sunday March 30, 2014

The Midwest Great Lakes SER Chapter held our sixth annual meeting at the University of Minnesota in St. Paul, Minnesota. The meeting was attended by 137 people representing academia, non-profits, government, industry, and consulting. The meeting goal was to highlight the legacy of ecological restoration in the Midwest and the importance of the linkages between theory and practice in ecological restoration. Our scientific agenda featured two plenary sessions, a keynote address, three symposia, one workshop, 16 contributed poster presentations, and 34 contributed oral presentations on a diversity of topics that reflected our meeting theme.

### 2. MWGL SER Michigan Career Workshop – Friday, October 24, 2014

The Midwest Great Lakes SER Chapter held our first state-level event at the Matthaei Botanical Gardens and Nichols Arboretum in Ann Arbor, Michigan. The workshop entitled "Career and Professional Development Opportunities in Restoration: A Student Workshop" received interest from 51 participant (34 attendees, 17 who asked to receive future information). The workshop was open to both members and non-members in order to provide restoration services to the region, attract potential new members, and provide a networking opportunity for existing members. MWGL SER members led the discussion on the restoration process (how to go from concept to completion) and career advancement within different sectors (how to go from student to boss).

## **Other Major Accomplishments**

Major chapter accomplishments for 2014 include the following:

- Addition of Iowa as a member state: Due to a high level of interest from Iowa restoration practitioners, the MWGL SER Board evaluated the expansion of the chapter to include Iowa. The MWGL SER Board received numerous letters of support for the expansion. The motion for expansion and updated bylaws were presented at the SER Board December 2014 meeting, where they were approved. Laura Jackson is serving as the interim Iowa representative to the Board.
- Held first state level event: The 5 year Strategic Plan calls for state level events to be held annually in addition to our chapter's Annual Meeting. The first state event was coordinated with the annual meeting for the Michigan Consortium of Botanists (MiCOB). The evening before the MiCOB meeting, MWGL SER sponsored a workshop entitled, "Careers and Professional Development in Restoration: A Student Workshop" at the University of Michigan Matthaei Botanical Gardens in Ann Arbor, Michigan. MWGL SER members led a discussion about the restoration process (how to go from concept to completion) and career advancement within different sectors (how to go from student to boss). The workshop received positive feedback from the 34 attendees and several new members joined as a result of this interaction.
- Streamlined membership options: MWGL SER has historically offered a "chapter only" membership option that was separate from SER membership. However, the "chapter only" membership option presented unique tracking and synchronization challenges. After much discussion, the board approved a vote to remove the chapter only membership option. We are excited that all of our chapter members will have a chance to experience the benefits offered by SER and that the chapter can take greater advantage of the existing membership tracking and retention infrastructure maintained by SER.
- Modernized our communications campaigns: In 2014, the chapter made a significant push to become more active on social media (Twitter, Facebook, LinkedIn) and our website. We began posting relevant job and internship openings, funding opportunities, and regional events and webinars. These social media communications allow us to provide our members with more interactive discussions and real-time information exchange.
- **Began conversion of newsletter to blog:** In an effort to provide more frequent and more flexible communications, we have begun the steps to convert our newsletter (previously sent out in PDF via email) into a blog. Rather than one quarterly newsletter, we will now be focusing on weekly or bi-weekly posts. Blog post topics will include member/project showcases, student perspectives, president's corner, and other chapter related news.

The SER Midwest Great Lakes chapter continued to implement the 5 year strategic plan by improving outreach, benefits, and services for members. The chapter's annual meeting "Building on the Midwest Legacy of Restoration: Linking Theory and Practice" in St. Paul, Minnesota was the largest yet, with 137 attendees from across the region. The MWGL SER chapter encouraged greater student involvement and recognition by providing several student awards at the annual meeting. The chapter's first \$1000 Student Research Grant was awarded to Amy Alstad, a PhD candidate at University of Wisconsin for her project "Seed size as a determinant of recruitment success in prairie restoration." In October, chapter members organized a successful student career workshop, "Career and Professional Development Opportunities in Restoration: A Student Workshop" at the University of Michigan.

## **Chapter Challenges**

- (1) We will be hosting quarterly webinars beginning in Spring 2015. This is a new technology for our chapter so we hope that the webinar learning curve is not steep. We are grateful to SER for the access and training on the gotowebinar software.
- (2) Managing our email campaigns, website, social media, and blog is a significant effort. We hope that use of some synchronization software (e.g., Hootsuite) will alleviate some of that strain.
- (3) We have been using Eventbrite for our annual meeting registrations. However, as far as we know, there is not a way to sync registrants against the SER member list. So, for example, a person could register as an SER member, but we have no way of confirming their membership status unless we manually verify after they have registered. It would be helpful if SER could work with us (and/or Eventbrite) to determine if it is possible to link the membership list to the registration system.
- (4) In the past we have not used any consistent branding (colors, terminology). We will be making a push this year to set up templates so that we are conveying a clear, consistent, professional image in our various outreach activities. We would appreciate feedback from SER to ensure

that our templates are consistent with SER's mission and preferences.

- (5) Like any group, we always have challenges with consistent commitments from Board members, which is largely due to the fact that this is a volunteer role and Board members are also actively involved in their careers and other commitments. We have tried to match the Board members to committees that match their interests so that individuals will be excited/interested in maintaining an active role.
- (6) The expanding role of the chapter in the region (awards, exhibits, state events, etc) has resulted in additional financial strains on the chapter. Although we are currently in good financial health, we hope to continue our fund-raising efforts to strengthen our financial position.
- (7) Currently, the committees are primarily comprised by Board of Directors members. However, in order to meet the goals of the Strategic Plan and to support member interaction, we would like to encourage chapter members who are not on the Board to join committees or help with event planning. We will continue to use our annual meeting and social media to alert members of opportunities for involvement.
