 - Completion of soils and vegetation Detailed Site Assessments (DSAs) to current criteria including preparation of DSA reports for senior professional review.
 - Complete Pre-Disturbance Assessments including project setup, field activities, and reporting.
 - Assist in Biological, Waterbody, Natural Site Assessments, Environmental Field Reports, Natural Area Management Plans, and Environmental Impact Assessments, as required.
- Prepare Phase I Environmental Site Assessment (ESA) reports including background information review, regulatory searches, interviews, aerial photograph interpretation, site inspections, and final reporting for senior review.
- Review background information and compile reclamation certificate application packages.
- Assist in preparation of annual proposed Reclamation Programs and budgets for clients.
- Uphold Ecoventure's strong commitment to the Health and Safety Program and represent Ecoventure in conferences and industry seminars as well as liaising with all levels of stakeholders.

- Assessment and Remediation:
