# Phenology Information and Tools for Restoration in the Southwest Workshop & Survey

Are you planning to attend the <u>NPN's Workshop at the conference</u>?

Would you find it useful to know when the invasive species you manage are likely to be vulnerable to treatment? Would you appreciate predictions of when to collect ripe seeds for your native plant community restoration activities? The goals of this workshop are to identify stakeholder needs and opportunities for collaboration between the USA National Phenology Network (USA-NPN; www.usanpn.org) and restoration ecologists.

During this session, USA-NPN staff will share information about existing phenology tools and data resources, and how they have informed decisions. Many opportunities exist to improve these products to better serve the restoration community by providing targeted information to supplement existing knowledge and best practices. We expect to conclude this workshop with a list of potential projects and plans for collaboration.

# RESEARCH ASSOCIATE - Plant Conservation Group San Diego Zoo Institute For Conservation San Diego, California

The San Diego Zoo Institute for Conservation Research is the largest zoo-based multidisciplinary research effort in the world. Based at the Arnold and Mabel Beckman Center for Conservation Research adjacent to the San Diego Zoo Safari Park, more than 200 dedicated

scientists carry out research vital to the conservation of animals, plants, and habitats, locally and internationally. It is located adjacent to the San Diego Zoo Safari Park is located in San Pasqual Valley near Escondido, California.

# Private Lands Biologist / Technician Grand Junction. Colorado

NRCS and REW have partnered to create the Private Lands Biologist/Technician position. The Private Lands Biologist/Technician will be responsible for delivering conservation programs and riparian restoration practices on private lands in Western Colorado.

The program will deliver technical resources to landowners and other land managers that integrate riparian restoration practices and NRCS supported conservation practices. Success will be achieved via direct contact with landowners with the goal of developing good working relationships. Improved relationships with private landowners will produce more effective on the ground practices which will be supported by REW resources and incentives provided by the NRCS and US Farm Bill.

Position will be located in Grand Junction, Colorado and will require travel throughout western Colorado. The incumbent is expected to work closely with NRCS personnel in the region, with direct supervision provided by REW. This is a full-time position with a comprehensive benefits package.
